The waiting list is kept from year to year. There is a 20% cap on out-of-town members according to the Bylaws. Out-of-town applicants are those who do not live in the Tarrytown-Sleepy Hollow school district.

Members are allowed to sponsor one applicant and co-sponsor two applicants per calendar year.

PROCEDURES FOR SUBMISSION OF AN APPLICATION FOR MEMBERSHIP

1. A member of the Club who wishes to sponsor an applicant for membership should obtain a copy of the "Application for Membership" form from the Club's Membership Chairman (who will note on the form the then-current bond value, initiation fee and annual dues) and forward it to the applicant.
2. The applicant should complete and sign the form and return it to the sponsor.
3. The applicant should: (a.) complete the application form to indicate his sponsorship of the application and the names of the two members seconding the application, (b.) prepare his own letter of sponsorship and obtain similar letters from the two seconding members, and (c.) forward the completed application, accompanied by the three letters, to Tarry Crest Swimming and Tennis Club, Inc., P.O. Box 215, Tarrytown, New York 10591.
4. On receipt of the application and letters, an acknowledgement will be sent by the Membership Chairperson to the sponsor and the applicant, indicating that the application is complete in all respects or that further documentation is required to complete it. In the latter case, a further acknowledgement will be sent to the sponsor and applicant when the additional documentation is received.
5. It is the responsibility of the sponsoring member to insure that an application is complete.
6. It is suggested that the applicant contact his sponsor if, within a reasonable period of time, the applicant has not received one of the acknowledgement referred to above.
7. A member in good standing may sponsor or second one application per calendar year.

PORTIONS OF THE CLUB'S BY-LAWS RELATING TO VALUE AND REDEMPTION OF BONDS

Section 3. (a) The Club may raise some or all of the funds necessary for acquiring or improving its properties and facilities, or for its operations, through the issuance of Bonds. The Bonds shall be non-interest bearing with the face value of \$375 each, provided that on March 1, 1971 and each of the nine succeeding anniversaries of such date, the face value of Bonds shall be increased by \$15 of the dues paid with respect to the year succeeding such date, to a maximum of \$525 on March 1, 1980. Additional increases as follows:

No Bond shall be issued for less than its face value.

- (d) Bonds shall not be transferable and each shall contain an appropriate notation to that effect on the face thereof.
- (e) A holder of a Bond may redeem his Bond any time after May 31, 1956, for the full face value thereof less any indebtedness owing by the holder to the Club, provided that if he was a member of the Club he has terminated his membership. The manner in which the Bonds shall be redeemed shall be determined by the Board of Governors provided, however, that each of such Bond shall be redeemed in the chronological order in which memberships terminate (except as otherwise provided in these By-laws), and only as soon as payment for a bond is received from an incoming Member. Except for the redemption payment as herein provided, each Bond shall become null and void upon the date that the holder thereof requests redemption of his Bond. The Club may redeem the Bond of an Member in accordance with the above provisions without his request upon cessation of this membership for cause, and after such redemption the bond shall be null and void.
